Travel app

A smartphone app setting out passengers' rights has been launched by the European Commission. Available for iPhone and iPad, Android, Blackberry and Windows Phone 7, it currently covers air and rail transport and will be extended to bus / coach and marine travel in 2013.

Vehicle roadworthiness

A three-part 'Roadworthiness Package' has been adopted by the European Commission. COM(2012) 381 is a draft Directive 'amending Council Directive 1999/37/EC on the registration documents for vehicles'; COM(2012) 380 is a draft Regulation 'on periodic roadworthiness tests for motor vehicles and their trailers'; and COM(2012) 382 is a draft Regulation 'on the technical roadside inspection of the roadworthiness of commercial vehicles'.

Human rights

The first EU Special Representative for Human Rights has been appointed. Under Council Decision 2012/440/CFSP, Stavros Lambrinidis takes up the new post - created after a long campaign by the European Parliament.

Eurostat's 148-page 'Pocketbook on enlargement countries' covers 2000-2010 and includes statistics on: demography, education, social conditions and labour force, national accounts, finance and prices, agriculture, energy, industry, construction and services, transport, communications and information society, external trade, research and development, and environment.

European Council priorities

The European Council has issued a summary of its priorities up to 2014, together with a tentative work programme. Amongst the issues highlighted are: Economic and Monetary Union (EMU), the Europe 2020 strategy, Enlargement, Key partners and regions, Defence, and the 'European idea'. The programme set out 'requires time and sustained effort' and the intention is therefore that the European Council should meet six times each year.

Social networks

If you've ever wondered if the EU has embraced social networking, the answer is 'yes - sort of'.

The European Commission's [Take part!](#) page on Europa brings together corporate and personal accounts for a variety of social media.

There's a list of a dozen blogs - mostly maintained by the Commission - links to Facebook, Twitter and YouTube accounts (the EU's YouTube presence is branded 'EUTube'), plus a short list of Flickr pages.

For the Facebook, Twitter and YouTube sections, a standard format lists the EU Institutions & bodies, agencies, Representations, Delegations, and policies (!) for which information can be found on that medium.

Not surprisingly, there are big differences both in the relative popularity of the networks and in the extent to which each is used. A quick glance suggests that Twitter is most popular with the EU, with the relevant page showing that the Commission DGs / Services have 19 tweeters and the European Parliament 22. For comparison, the Facebook page lists 11 and 4 respectively, with YouTube having 4 and 2.

It's very hit-and-miss at the moment, with no guarantee that any of the social media will be used by a specific institution or to promote a particular policy. There's no claim that the lists are comprehensive, and they can be expected to change over time, but they do provide a convenient source of links for what are becoming increasingly useful sources of information.
